About the Grant Fund

The Grant Fund is mainly aimed at community and voluntary organisations, and each County Councillor is allocated £5,000 to support small-scale community-run projects that meet local needs. This could be through running a project or event, improving a facility, or purchasing equipment.

You will need to apply to a named Councillor (see details overleaf), and we advise that you discuss your project idea with your local Councillor before submitting your bid. If you are not sure who your Councillor is, or **if your project covers more than one Council Division, please liaise with the Area Team.**

We expect applicants to have a constitution and a bank account. Where this is not possible, you will need to find another agency to act as a 'sponsor' for your project and to administer the funds.

We expect applicants to have appropriate insurance, to be committed to equalities and diversity, and to have appropriate arrangements with regard to health and safety and safeguarding children and vulnerable people.

We will not fund...

- Private businesses or profit-making organisations.
- Statutory organisations such as County and Borough Council, Police, and NHS agencies.
- Contributions towards major refurbishment, building or maintenance work costing over £5000.
- Groups that have failed to account for the expenditure of any previous grants.
- A contribution to an organisation's running costs for an unspecified purpose.
- Projects that promote religious or party political beliefs.
- Projects which have already taken place before the grant has been agreed.
- Prizes
- Loan or debt repayments

Please note that WCC, at its discretion, may choose not to fund a project that is politically sensitive or contains politically sensitive elements.

Application Process

Please submit the application form by email to northernareateam@warwickshire.gov.uk, or by post to WCC Northern Area Team, Room 101, Town Hall, Coton Road, Nuneaton, CV11 5AA.

Your application will be acknowledged within 5 working days. We may also contact you to ask additional questions in relation to your application.

If you are successful, we will notify you of arrangements for receipt of funding. Once the project is complete, you will need to provide a monitoring report to show the grant has been spent in line with the application. If you are unsuccessful, we will let you know.

There is no closing date for applications, but we encourage you to apply early.
You may contact us to find out if your Councillor has already spent their allocation for the year.
