|  | <p>Jane Smith, Community Engagement Team Leader<br/>Nick Berg, Design Manager</p> <p>Nick presented the proposed ecological mitigation works for key sites in Area North 1.</p> <p><b>Burton Green</b><br/>Plans for ecological mitigation include:<br/>Black Waste Wood – improved management of woodland, ponds, grassland. Woodland planting to screen rail track.</p> <p>Village hall to be demolished and new one built.</p> <p>Potential to enhance land between site of new village hall and designated environmental mitigation site as an amenity asset for the village. Burton Green Parish Council to consider options. The land is currently owned by HS2, possibly on a temporary basis. Susan to clarify.</p> <p>PROW enhancements also proposed.</p> <p><b>Kenilworth</b><br/>Several sites for ecological mitigation proposed along route.<br/>Plans for ecological mitigation include:<br/>Translocation of ancient woodland soils at Broadwell Wood which will be crossed by the track near its southern boundary.</p> <p>Kenilworth Greenway diversion – hedgerows have already been removed to prepare for the diversionary route.</p> <p>New hedgerows to be planted to link up existing and new areas of woodlands. Designated arable fields along route to be planted for woodland. The Hedgerow Regulations 1997 protect newly planted areas.</p> <p><b>Cubbington</b><br/>Plans for ecological mitigation include:<br/>Consent given by Environment Agency for woodland planting in flood zone to screen track.<br/>Woodland planting area is designated west of Cubbington Woods<br/>Possibility of ‘green bridge’ installed at cutting through South Cubbington Wood.<br/>PROW to be kept open.</p> <p>Copies of the latest HS2 brochure ‘More than a railway’ were handed out</p> <p>In response to questions:</p> <ul style="list-style-type: none"> <li>• Not aware of more land parcels being acquired either temporarily or permanently in accordance with HS2 Act 2017</li> <li>• Clarity to be sort over keeping of freehold land rights by</li> </ul> | <p>SB</p> <p>SB</p> |

Most have been discussed in House of Commons and appropriate diversions have been agreed</li> </ul> <p>Discussion about the lack of provision of 'green bridges' for the movement of wildlife 'across' the track identified that no green bridges are confirmed in North Area, Warwickshire, the nearest being in Central Area at Wormleighton, Warwickshire on the Oxfordshire border. The track will be a physical barrier for wildlife creating separate communities either side of the line with little chance of interaction, in particular for deer and badger. It was requested that more green bridges in Warwickshire are included in the final design plans.</p> |  |
| 8. | <p><b>Presentation: A46 Link road at Stoneleigh</b></p> <p>Nicola Van der Hoven, WCC gave an update on the road junction proposals. The existing bridge over the A46 will remain with a new one constructed to the north to create a gyratory system. The majority of the construction of the new junction should be complete with minimal disruption to traffic flow on A46.</p> <p>The plans show shared use footpath / cycleway around the perimeter of the roundabout with Toucan crossing points.</p> <p>Final funding decisions expected in September 2018 from West Midlands Combined Authority and towards the end of the year from Department for Transport.</p>  |  |
